1. **Call to Order:** Vice Chair DeSiervo called the meeting to order at 7:03 p.m.

2. Additions and Deletions: Snelling requested that discussion and approval of the most

recent WRC invoice be added under New Business. DeSiervo asked that a discussion of Windham Windsor Housing Trust be added under New Business. There were no objections to the two

changes.

3. **Members of the Public:** Mike McConnell from WRC is attendance to assist with Town

Plan discussion

4. Approval of Minutes: Matschke moved and DeSiervo seconded a motion to approve the

minutes of September 11, 2024 as submitted. The motion passed.

5. Correspondence: A) Email notice from Agency of Natural resources and Natural

6. Old Business: Town Plan: The Commissioners reviewed and discussed the

comments, suggestions, changes to the Land Use section. It was noted that the language in the Town Plan will be consulted and considered in Act 250 applications. There was a question about what bylaws can be adopted other than zoning. DeSiervo will research the state statutes on what bylaws are permissible. DeSiervo reminded the Commissioners to look over the community assessment based on the 2020 census data. It shows

that the community is only growing very slowly and the average

age is rising dramatically.

Town Hall: DeSiervo reported that the architect is working on the bid specs. He discussed the ramp material options and that wood or concrete wood cost about the same but concrete would be more durable. The architect understands that the rest room may be modified or removed if there is major renovation and hence is

looking to do it inexpensively.

Matschke let the Commission know that a grant had been submitted for repairing the roof. The Planning Commission was asked to provide \$1473 from the reserve fund as part of the match. It was discussed that this shouldn't be a problem.

7. **New Business:** Budget FY 25/26: Snelling circulated a copy of current budget

<u>WRC Invoice:</u> Snelling stated that WRC had submitted an invoice for \$630 covering work on the Town Plan in September. Matschke made a motion, seconded by DeSiervo, to approve payment of the WRC invoice. The motion passed.
