- a. Administration budget presentation: Frank presented to the board 5 different scenarios of the budget. A lengthy discussion ensued. Kim made a motion to pass the budget for FY15 in the amount of \$1,416,472.00. This is a 1.2% increase in expenditures for the year. Motion carried.
