Superintendent's Report: Steven presented a graph of Vermont Public School Enrollment Declines Not Likely to be Reversed Soon---There are currently 320 students enrolled at L&G, the enrollment has declined sooner than they thought. The board wanted to know what about the state enrollment, the graph Steven presented showed there isn't too much difference with the state stats.

L&G's budget was voted on and passed. Steven also had information re: the warning needed from L&G by the state. Townshend has 70 students enrolled at L&G currently and last year there were 80.

Consent Calendar was approved unanimously. Cliff made a motion to approve consent calendar as written. Seconded by Brud.

## **Unfinished Business and General Orders**

- a. Act 46 updates: Steven talked about different options with other schools. Close the school-stay with L&G, Pre-K-12 choice. WCSU board has engaged in a \$5,000 exploratory grant that will give you some help in getting a study committee together.
- b. FY17 Budget: The board had some questions for Steven to ask Bud and return with answers for the board. Special Ed-given current knowledge does it have any impact as to next year? Steven said it is based on your service plan. Service Plan for this year is based on what we have, it is very hard to predict as far as special education costs.
