Unfinished Business and General Orders:

a. Professional Development follow-up. L&G gave a copy of their calendar to Craig to review with the board. Craig is very thankful to the board to allow the staff to start this year with extra PD days. Craig asked the board if this was something we want to do in coordination with L&G. There are 6 PD days for next year. Dates are: September 12-October 10-November 7th, December 12th, March 13th, May 8th. Craig feels 6 PD days would be well filled. Math is a focus within the district and Townshend is very invested in doing PD re: Math in August. The board wants the teachers to have full buy into PD. Board wants teachers to write to the board to see how they would like to receive PD days, how many days, why and what. Craig was asked to bring back the results to the next board meeting.

New Business:

- a. Engineering Study, 3/19 Craig reported this in the Principal's Report
- b. School Advisory Committee: Craig had spoken with Al about a conversation from the MUDD meeting in March, this came from AOE, roles and responsibilities in Vermont school systems. By fall of 2019 schools will be asked to have a School Advisory Committee. Craig presented this to the board for their input. We want people from community invested and involved in the school. Al said we are forming the MUDD and should probably reach out to the other schools and have other ideas from other folks. Al thinks it is important to collaborate.
- c. Hiring: The hiring of the kindergarten teacher is on track and the window closes on Sunday. Craig will send the information and his final recommendation to the board.
- d. Act 46 Study Committee Bill Back: We had an overspend on the Act 46 Committee way back. We will need to pay about \$2800. More informational to be guided to make a motion next month.
- e. Firearms and Freedom of Expression Policies came out in March to come out in our handbooks. The Freedom of Expression and Firearms policies were adopted in 2006 and are required policies. These need to be reviewed, warned and approved.

Cliff made a motion to warn Code C5 Firearms Policy. Motion carried. Cliff made a motion to warn Code C11 Freedom of Expression Policy. Motion carried.
