5. Reports:

a. Financing through VT Municipal Equipment Loan Fund

Hege asks for bid decision from group to complete loan form. Frisk opines to go with Patriot/ATG (with trade-in). Bissonnette motions to purchase truck from Patriot with using funds from Municipal Equipment Loan Fund. Mansfield seconds, carried by all.

b. Purchase of new dump truck- Can borrow \$110k or 75% of purchase price (\$170000 * .75 = \$127500). Frisk asks to use \$50,000 set aside for grader toward purchase. Borrow \$110,000 through state loan, 2% @ 5 years, raise the additional \$10,000 via taxes for 2020. Bissonnette motions, Frisk seconds, carried by all.
