1. **Meeting Call to Order:** Lake calls the meeting to order at 6:02pm

- 2. **Approval of Minutes:** Wright makes a motion to approve the December 12, 2023 regular Selectboard meeting minutes. Marrow seconds the motion. Motion carries 5-0-0.

3. **Town Clerk:** Lake gives the report. The Town Clerk brought in \$882.50 in fees and services.

8. Old Business:

a. **Road Name change request:** The Select Board takes up the recent request to reach a decision on the Taft Hill Trace road name change request from Mat Brody. Wright makes motion to allow Mat Brody a change of address to one on Gale Road. The motion is to assign him a number on Gale Road. Felker seconds the motion. Motion carries 5-0-0.

9. **New Business:**

- a. **West River Sno Goers Club request:** Lake reads the request of the snow mobile club to use certain parts of town roads. Wright makes a motion to allow the Sno Goers Club use of the roads listed in their request. Felker seconds the motion. Motion carries 5-0-0.
- b. **Draft Budget discussion and approval:** Lake presents the Select Board the draft budget for discussion.
- a. The Board discusses the Planning Commissions proposed budget including a \$26,000.00 request for a new town plan. Andy Snelling and John Evans speak to the proposed budget. The Select Board asks questions and express concern about the \$26,000.00 for a Town Plan. Wright makes a motion to table the issue until the 1/9/24 Select Board meeting in order to give Windham Regional Commission time to submit revised costs. Marrow seconds the motion. Motion carries 5-0-0.
- b. The Budget Committee brings to the attention of the Board the significant increase in healthcare costs effective 1/1/2024. The increases are due to having a full staff on the road crew, and a 14% BCBS increase in premiums. The Budget Committees recommends paying the full cost of the increase through June 30, 2024. In the mean time, the committee recommends putting together a healthcare committee to research other options on healthcare.
