- 1. **Meeting Call to Order:** Evans calls the meeting to order at 6:10pm.
- 2. **Approval of Minutes:** Suarez makes a motion to approve the December 19, 2024 regular Selectboard meeting minutes. <Marrow seconds the motion. Motion carries 3-0-1

- 5. **Executive Session:** Personnel V.S.A 313(3): Evans makes a motion to go into executive session. Suarez seconds the motion. Motion carries 4-0-0. Selectboard goes into executive session at 6:12pm. Evans reconvenes the meeting at 6:25pm. Suarez makes a motion to increase the Selectboard Assistant position form 20 hours per week to 30 hours per week. Marrow seconds the motion. Motion carries 4-0-0.

 - 3. **Town Clerk:** Evans gives the report. The Clerk took in \$1,660.00 in fees and services.
 - 4. Chair: Evans reports that the Selectboard has been working hard on the budget.

9. Old Business:

- a. **Vote on Town Budget:** The Selectboard set the date for a special selectboard meeting to finalize the budget. The meeting will be held on Monday, January 20, 2025 at 3pm at Town Hall.
- b. **Review of initial draft Warning:** The Selectboard discusses the draft warning. Holt is directed to discuss the warning with the moderator. Lake suggests providing a breakdown of the highway funds article for the voters.
- c. Acknowledge the signing of the Act250 Impact Questionnaire: Evans reports that after the last Selectboard meeting she met with Andrea Seaton to get more information on the questionnaire. Grace Cottage also met with the Fire Chief. Questions and concerns were answered, and she signed the questionnaire as the Selectboard Chair.

10. New Business:

- 1. VT Historic Preservation Grant: signature for Town Hall Roof Repair: Marrow reports that the Town has obtained a Vermont preservation grant for the repair of the Town hall roof. Suarez makes a motion to authorize Selectboard Chair, Allie Evans, to sign on behalf of the Board. Lake seconds the motion. Motion carries 3-0-1.
- 2. **VTrans Certificate of Highway Mileage:** The Selectboard sign the VTrans Certificate of Highway Mileage.

- 3. **Town Hall Use Request:** Marrow makes a motion to approve The Rest 2025 Interactive Workshop request to use Town Hall on 2/22/25 from 7 5:30pm. The fee charged will be the fee in the amount if the draft policy that has been in effect and operating under. The approval will be contingent on the organization providing a certificate of insurance. Suarez seconds the motion. Motion carries 3-0-1.
